COURSE RETAKE POLICY

Students may retake a course once to improve a grade lower than C or if the grade earned does not meet admission or progression requirements for a major. Both grades received in the course are entered on the transcript. The higher of the two grades will be used in calculating the grade point average. Credit will be given only once. In the event the course was failed in both of the previous attempts, no credit will be awarded for any additional attempts.

If, after taking the course a second time, a student has not achieved the required grade, the student should meet with the student's academic faculty advisor to discuss implications. If a student needs to take a course more than twice to progress in their major, the student must obtain written permission from the Department Chair responsible for the major, and in cases where the required course is offered outside the department of the major, written permission must also be obtained from the Department Chair from the offering department. Permission(s) must be provided to the Registrar's Office prior to processing the registration.

Any course taken more than twice is entered on the transcript regardless of grade earned for progression purposes only. No additional credit or change in GPA will occur.

Courses transferred from accredited colleges or universities may also be used under the Course Retake Policy. For a course to be accepted, a grade of "C" or better must be attained. As is true for any course transferred into Keene State College, the grade is not entered on the transcript nor calculated as part of the grade point average. The original grade earned at Keene State College will no longer be factored into the grade point average, but it remains on the transcript. Students taking advantage of this policy must register for the course, pay tuition, complete a course retake form and, if necessary, a course substitution form.

Opportunities to use the Course Retake Policy end upon baccalaureate graduation. If a graduated student wishes to retake a course completed as part of their undergraduate program, written permission must be submitted by the course instructor to the Registrar's Office. The grade for a course retaken after a degree has been conferred will display on the transcript, however, no GPA points will be earned. If the student does not need a grade for the course, the course should be audited. The Course Retake Policy does not apply to courses taken for graduate credit.

KSC Educator Preparation Programs Retake of Clinical Experience Course Policy

Overview

Teacher candidates may progress through foundational coursework in Educator Preparation but subsequently (a) earn below a C in, (b) withdraw from, and/or (c) otherwise not meet expectations in a clinical experience course. This Retake of Clinical Experience Course Policy addresses the opportunity (or not) to retake a clinical experience course. Due to the responsibilities of working within the larger community during a clinical experience course, there exist limitations for teacher candidates seeking to retake such a course.

- Any retake of a clinical experience must be approved by program faculty and Educator Preparation administrative staff.
- Teacher candidates only have the opportunity to retake a clinical experience course once.

- This retake policy will apply in any situation in which a teacher candidate (a) earns below a C in, (b) withdraws from, and/or (c) otherwise does not meet program or Educator Preparation Office expectations.
- This retake policy applies to any course with a clinical experience component (e.g., Methods courses, practicums, student teaching, etc.).
- · Teacher candidates may only retake courses for up to 3 years.

Candidates for Retake of Clinical Experience Course

The opportunity to retake a clinical experience course will only be considered for teacher candidates in specific circumstances. While the list below is not exhaustive, it serves to illustrate the sorts of criteria likely allowing a retake to be possible:

- If a teacher candidate cannot satisfactorily complete a clinical experience course due to physical or mental health reasons, family obligations, College-approved Leave of Absence, military deployment, or other unavoidable disruption.
- If program faculty evaluation of a teacher candidate suggests that satisfactory improvement in pedagogical skill and/or professional dispositions is likely in the retake of a clinical experience course.
- If a teacher candidate has met all previous Educator Preparation
 Program Decision Points necessary to take the field experience
 course. If a teacher candidate seeks to retake a clinical experience
 course, the form below must be completed in full and signed by
 all people indicated below. Please see the full Retake of Clinical
 Experience Course Policy in order to guide your Request to Retake
 letter and well as for more information about the circumstances in
 which a retake is most likely to be possible.
